WELCOME

This Agreement sets out the legally binding terms for your use of the Site and membership. This Agreement may be modified by Samata Bhratru Mandal from time to time. The membership and rights of admissions are reserved.

This Terms of Use is published in accordance with the provisions of Rule 3 (1) of the Information Technology (Intermediaries Guidelines) Rules, 2011.

The platform developed is for the personal use of individual members to advertise and promote their profiles for the purpose of finding relevant matches and cannot be used in connection with any commercial endeavours.

This platform is a world class matchmaking platform to seek a life partner and is not a casual dating site.

Access to the Samata Bhratru Mandal website or mobile application for registering your profile is free. However, we offer Premium Memberships wherein one can promote his/her Profile on various Samata Bhratru Mandal properties such as Premium Interest Wall, Inbox, Search Results, video chat, etc.

Samata Bhratru Mandal Matrimony service gathers following types of information:

Information that you submit

In order to avail the service you provide the following information:-

- ✓ When registered for our service, you share with us your personal details, such as name, your gender, date of birth, contact details, educational qualification, employment details, photos, marital status and your interests etc...
- ✓ When you avail for a paid service, you provide us or our payment service provider with information, such as your debit or credit card number or UPI.
- ✓ Details shared with our customer care team. (This information used to monitor or for training purposes and to ensure a better service)

- ✓ You have the option to send interesting profiles bookmarks to your parents, then we
 will use their email address or mobile number to send a one-time message to them
 per request.
- ✓ Your chats and messages with other users as well as the content you publish will be processed as a part of the service.

• Information which is not directly submitted by the you

- ✓ User activity: We collect information about your activity on our services, such as date and time you logged in, features you've been using, searches, clicks and profiles visited by you, your interaction with other users including messages exchanged.
- ✓ Device Information: We collect information from and about the device(s) such as IP address, device ID and type, device-specification and apps settings, app error reports, browser type and version, operating system, identifiers associated with cookies or other technologies that may uniquely identify your device or browser.
- ✓ SMS permission: We need SMS permission for authenticating transactions via OTP, sent by the Payment Gateway.

Information we receive from others

SECTION 1 - WHAT DO WE DO WITH YOUR INFORMATION?

We use the information collected in the following ways:

When you browse on our website or on our mobile application, we also automatically receive your computer's internet protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system.

Email / SMS marketing (if applicable): With your permission, we may send you emails about our store, new products and other updates.

SECTION 2 - CONSENT

How do you get my consent?

SECTION 3 - DISCLOSURE

SECTION 4 - PAYMENT

We use Razorpay/PayU for processing payments. We/Razorpay/PayU do not store your card data on their servers. The data is encrypted through the Payment Card Industry Data Security Standard (PCI-DSS) when processing payment. Your purchase transaction data is only used as long as is necessary to complete your purchase transaction. After that is complete, your purchase transaction information is not saved.

Our payment gateway adheres to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover.

PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.
